Cindy-Pilates for Dressage clinic needs to be moved, TDF is giving us a grant to put on the clinic. Dates were discussed among the group. It was decided that the 16th -19th would be the best date to hold the clinic.

Since board approval for the clinic was tabled at the last meeting due to funding issues, Cindy proposed that we put on the clinic approving the potential loss of \$400. Sarah seconded, all approved.

Cindy also discussed putting WNCR's fundraiser on our website in order to advertise this to our membership.

Susan-reviewed the USEF high school letter program for youth. Susan mentioned that she would reach out to youth members to gauge interest.

Results of the member survey-

Cindy & Amy will be able to share the results with the rest of the board using the share function of the drive.

We received 29 responses so far

28% of respondents want a clinic from a top rider

28% want a seat focused clinic

27% want a test riding clinic from a judge

We decided to make a deadline for month end. Maribeth will send a blast to get more feedback

Sarah mentioned that the amount of responses we are getting is much larger than the last paper survey we sent out a few years ago.

A list of proposed clinicians were discussed.

Maribeth discussed alternatives to using an "r" judge for the June show. Partnering with SFDA to advertise the June show will help fill it. The June show will be a USDF regional schooling show qualifier.

We talked about moving the July show to CTF.

Sarah brought up that we need donations for the tack swap to increase inventory.
