Membership in that period was \$1,675.26

We have to send \$1,492 to USDF

Schooling Show income was\$4534 .49

Expenses were \$2988.26

Profit was \$1246.23

Virtual show income was: \$1360

Expenses were:\$720

Regular annual expense

Liability insurance \$918.32

Board of Directors liability \$1142

USDF donation was \$50

Test prizes, ribbons etc: \$34860 PO box and office supplies- \$294.83 Donations to other organizations: \$375.

So the education fund had a loss of \$306

Overall there is a loss this year. Financially we are in good shape but can't lose every year.

Maribeth suggested that the Feb meeting be a budget meeting. She will send out data and spreadsheets before meeting so everyone can peruse them beforehand and have suggestions and questions ready. This is to focus on finances and come up with scenarios to return to profitability.

Susan- Has been in touch with Brittany Sontag about using the 4H arena. We can use it for free if we have something for the 4H kids. Her idea was to offer a Western Dressage Clinic to them then have time for them to practice before having a show there. Then the venue would be free for us. They are working on the footing of the arena.

She also told us about the USEF Academic Equestrian Group that youth can participate in to earn letter for letterman's jacket. This group is for youth 6th-12th grade. They need 100 hours of riding/lunging time or 3 shows (schooling or rated) to qualify. Issues with this are the cost of having a USEF membership.

Minutes were approved

We are over TDF money from last year. \$10 for training level test 3. We already approved this as an expense so Maribeth will look it up and send out a check.

We also threw ideas out about the USDF Convention-inclusion of non-typical (for us) classes in our shows

Caprilli classes and carriage classes were suggested to be added to our shows. Welcoming non typical classes into our shows. Concerns were: 1. Do any of our judges know how to judge this? 2. Warm up areas for carriages 3. Riding horses freaking out 4. Is there enough of them to include in the show and who has contact with them in the community. Susan has a neighbor who she will talk to. Maribeth thinks the northern community might show up. And just start having pre-caprilli students go ahead and show. Insurance covers all. Susan has one youth who could maybe demonstrate this.

Maribeth will also be asking someone on the board (except John since we pay him) to help out with the treasurer's report until we find a new treasurer.
