Western Dressage

In August of last year, the Juan Tomas Hounds sponsored a fun, Dressage show at the Corrales, Top Form Arena. Maureen Baca managed the show and Marybeth Perez-Soto judged. Julie Wilson rode her horse, "Boots". After the show, I received a wonderful email from Julie, which went as follows. "I'd like to express my joy at having had an opportunity to ride my Quarter Horse in a Dressage show, using my western tack. I love both disciplines and yearned for an opportunity to blend his (Boot's) skills. She went on to say that....."The judge provided me with an excellent critique of those, (my) decisions and our execution – something Dressage is so good at doing,"

Julie used her barrel racing saddle because it provided a closer contact with the horse. In the interest of protecting herself from the sun, she wore her western hat but totally supports the use of helmets. She elaborated on the concept of breaking down barriers of tack and attire in order for riders to focus on horsemanship and training.

Also, Julie presented the concept of encouraging more riding without drawing strict lines about tack. Most western riders acknowledge the common techniques used by ropers, barrel racers, and pleasure riders that include Dressage principles. She said, "What is needed is to find those common techniques, work through the challenging, human interpretations of (things like) how bits work and get folks to ride their horses in better harmony. Let's work on how we can meld, blend and grow the events we already have in place with Western, Dressage and Hunt Seat."

In 2009, AQHA approved classical Dressage events with conversion scores to AQHA points. Not only will this open up opportunities for more "crossing over" of breeds in our events but it will provide educational opportunities for Quarter horse owners.

Julie Wilson manages shows for the New Mexico Quarter Horse Association and is actively pursuing the development of more beneficial relations between NMQHA and NMDA.

April 16th, Dinner and Discussion at the Hotel Andaluz: Social hour, 6:00 to 7:00 pm in hotel lobby, followed by plated dinner in the Mallorca Room. Ms. Gurney will show a DVD and lead a discussion. She will also entertain your questions about the current state of Dressage.

Will there be a process to select riders if you get more entries than slots available? I will be making those selections by phone or email

How many openings are available at both events? There is room for 55 dinner participants. Ms. Gurney will teach eight, 55 minute lessons at the clinic. We can accommodate 65 auditors.

What levels will be addressed? We plan to have Training Level through Grand Prix.

What will it cost to ride in the Clinic? \$175...this includes one dinner ticket and one lunch voucher.

What is the cost of just the dinner/discussion? \$45 - however, the first 30 to sign up will pay only \$10.

What is the cost to audit? \$45 – The first 50 to sign up will receive a \$10 lunch voucher.

USDF Convention Report—December 2 - 6 2009

Rusty Cook attended the 2009 USDF Convention and prepared this report: for the NMDA Members:

- Proposed budget presented revenue is down, expenses are up. No USDF benefits to members have been cut. Complete Budget report available at http://www.usdf.org/about-usdf/financials/index.asp
- Suggestions were made to move the focus away from competition and on to education'
- For Regional News, see Terry Hunt's report, this Newsletter.
- 2010 Championships will be in Colorado, over the Labor Day weekend. It will include the Stallion Showcase as done previously.
- Arizona has bid for the 2012 show.
- A Scholarship committee has been established to award scholarships in 2010.
- The Sport Horse committee proposed having a "current year foals" class, fillies and colts in one class. Changes in the judging were discussed.
- October 30 & 31, there will be a Sport Horse Seminar at Horses Unlimited, in Albuquerque.
- Regional Championship Committee reported receiving over 800 evaluations, using the on-line survey form.
- The Four-in-one Forum (Competition Management

Council, Competitors Council, Judges Committee and TD Council) Discussed ways to improve competitions. Judging consistency was an important issue. A suggestion was made that shows not hire judges who are either too generous or too hard on riders.

- The summary of the year's progress (Moving the headquarters, more efficient record keeping, etc.) for more info, see the USDF website.
- Council and Committee reports are available online. A new Membership category, Education Membership, was established. Additional dues increases were approved. There will be a slight increase in other fees; Said fees do not go into effect until December of 2010.
- There will be no CDIs in 2010. No CDI-Ws in Calif., or the western US, in 2010.
- The Young & Developing Horse committee announced a Green Grand Prix for horse "about" eight or nine years old.
- Test Writing committee: New tests will be used December 1, 2010. The number of tests in Training level thru Second levels, has been reduced from 4 to 3. A rising trot will be allowed through First Level. Test times will be shorter. There will be more definite delineations between levels, especially between Fourth and PSG. For more information, see USDF site.
- Linda Zang and Brentina were inducted into the USDF Hall of Fame. Awards to New Mexico residents may be seen on the USDF website.

A Minute with the Board—December Meeting

Schooling Show Update – Changes in schedule reviewed. Motion made and approved to have NMDA pay for Bill Woods' judging fee and part of his transportation for judging a NMDA schooling show in Taos which will follow a Clinic that is sponsored by Taos Equestrian. This show will count toward NMD Year End Awards

Newsletter – Proposed and approved to have six, twelve page newsletters per year instead of twelve, with mailing by US Mail to those who have requested it. In between the months, publish shorter versions of the newsletter on the website only. The purpose is to reduce costs, concentrate more on content and quality and encourage the use of the web.

GMO Convention Report – See report in this publication.

Handbook Publication – Susan will be coordinating the publication. Plans are to send it out end of January.

Hilda Gurney Clinic – Jim Porcher from AHANM provided handouts and details of the clinic, being held April 17 at Cherry Tree Farm. Jim is seeking all levels of riders and hoping to have some participation from NMDA members. The Board approved giving NMDA mailing labels so AHANM can send a postcard to NMDA members (at no cost to NMDA).

AQHA Welcomes Dressage – Julie Wilson from NMQA described a program that the American Quarterhorse Association is developing to award registered AQH competing in USEF/USDF approved shows with AQHA performance points. Julie will be working with Donald to coordinate the process.

Proposal for Schooling Show Committee - Denai Meyers presented proposal for a committee to support the Schooling Show Chair. Everyone agreed that it will help to have a pool of volunteers to support the shows and thanked Denai for offering this support, encouraging her to work with the Chair and the Managers. Since the need for more managers was recognized, Barbara volunteered to put on a show manager seminar.

Ride Re-Ride Decision – It was agreed by Board members present, that each first ride for each rider and each horse/level will be counted towards the year end awards. So if one rider rides more than once or more than one horse, each first ride will be counted towards awards.

Schooling Show Entry Form - A proposed was approved to have one standard schooling show form. It can be published in the Newsletter and posted on the web site. Please refer to attachment.

Year End Awards Proposal - A proposal was approved to have NMDA offer two sets of Year End Awards, one for the Schooling Shows and one for Combined rated shows and schooling shows. A decision was not made at the meeting. The proposal will be sent out by email for a vote.

Meeting adjourned at 8:30 pm.

<u>Open Door Policy</u>: Board Meetings and General Membership Meetings are open to members and others interested in Dressage. At Board Meetings only Board members may vote. At General Membership Meetings, only current members may vote.

In one case, a judge was overheard discussing the following topic.

The theme of this **Observations** is that we need to hold ourselves to a <u>much</u> higher standard. New Mexico is known for its' "laid back", relaxed attitude. It may be a definite plus when compared to the hectic, rushing environments of other areas. But, according to some observers, that attitude has crept into our Dressage community. In other areas of the country, it is difficult to tell a clinic or schooling show from a rated show. Everyone is properly turned out. Perhaps we take "casual" too far?

Among the comments that came in was that the "Professionals" should be setting the example. If they attend a show, it should be in correct attire and on a clean, properly turned out horse! Correct attire does not need to be "show attire" for schooling shows. However, cleanliness, acceptable attire and proper tack are expected. A "Professional", riding at a recognized show on an improperly groomed horse and with dirty tack, unkempt clothing or martingale stops on the reins, does not set the proper example. There are those who feel that it does not matter whether it is a rated show or not. The turn out should be correct, regardless. Those who learn by watching will receive the right or wrong message, depending, etc., etc.

The conduct of the Professionals is under scrutiny, as well. How do they handle themselves after a disappointing performance? Are they on time for their classes? How do they behave in the warm-up arena? What is their attitude toward students?

In an attempt to ease the burden of the Professionals, it has been suggested that the rest of us observe, very carefully, in order to set our own standards. Once determined,

these standards should be adhered to at all times, until they become second nature. Turning out for a lesson should be a matter of pride. It also shows respect for your Instructor. Take that one step further – whenever you are on your horse, on the trail or in the arena, take pride in your appearance. You never know who may be looking to you as an example.

In keeping with the *higher standard* theme, suggestions were made that NMDA raise the qualifying scores for awards at Training shows. This would raise the performance level, overall, and make the "automatic Championship" worthy of the honor. (Automatic Championship is when there is only one horse competing at a given level).

Another comment was that many riders are not able to work with an Instructor, on a regular basis. The following has been suggested. Judges at schooling shows could make comments and a short corrective suggestion. Instead of simply using an "O" to indicate a circle, (which means ???) Perhaps stating, "Not round, needs more inside leg", etc., might be helpful. The scribes would have to be attentive and guick but it would help those riders immensely. There was a time, when a judge, at a schooling show, would step out and visit with some, not all, of the riders, after the final salute. It took just a few minutes and a lot could be said that couldn't be written in that amount of time. Even if the time schedule had to be tweaked a bit, it would be worth the little, extra time. Often, all it takes is that one, kind, helpful word. It has also been suggested that judges, at schooling shows, turn out more professionally. After all, these are Schooling shows.

Perhaps, we could all add "set a higher, personal standard" to our list of New Year's resolutions. It isn't difficult, it just takes awareness and commitment. The results could be so satisfying. It's much easier than trying to lose weight. Among the suggestions, for this particular column, was that perhaps we should write a one-time article dealing specifically with suggestions for setting that higher standard and offering a "do and don't list. Would that be helpful?
